MATLAB<br><b>Point No. 2</b><br><b>Reply</b><br>No dedicated budget fund has been separately allocated exclusively for the purchase of educational software during the aforesaid period. Microsoft Windows, Microsoft Office and Microsoft Windows Server licenses were procured as factory-preloaded software along with the purchase of computer systems. For ERP software, an expenditure provision of approximately 2 3 lakh has been maintained since its implementation, and renewal is carried out on an AMC basis as per requirement.<br><b>Point No. 3</b><br><b>Reply</b><br>The information is the same as provided in the reply to Point No. 2. No separate expenditure records are maintained exclusively for software that is procured as part of computer systems. ERP software expenditure is incurred as per AMC renewals and contractual requirements.<br><b>Point No. 4</b><br><b>Reply</b><br>ERP software has been operational since the establishment of the Institute. MATLAB has been availed through the Institute's mentor institute, Maulana Azad National Institute of Technology (MANIT), Bhopal. Microsoft Windows, Microsoft Office and Microsoft Windows Server licenses have been procured along with desktop computer systems as supplied by vendors. Separate year-wise software-wise expenditure records are not maintained in the requested format.<br><b>Point No. 5</b><br><b>Reply</b><br>The Institute follows prevailing Government procurement rules, tender conditions and institutional requirements for acquisition of software. ERP software is renewed as per the terms and conditions of the contract work order issued to the service provider and is generally renewed on an AMC basis. Microsoft products are procured as part of computer procurement in accordance with the terms and conditions specified in the relevant tender bid documents.<br><b>Point No. 6</b><br><b>Reply</b><br>No such consolidated record document is available in the requested format.
