4. It is informed to the applicant that acquisition & renewal of all the LC databases and software are held after the consideration & approval of the committee, and the final approval of the competent authority.

The query raised by the applicant regarding providing the Office Memorandums, Minutes of Meeting, Official Communications, or internal communications recording, etc. I would like to state that the data sought by the applicant is voluminous and scattered over numerous files and would require compilation, which is beyond the purview of the RTI Act, 2005. It would also disproportionately divert the resources of the Institute. Hence, the information cannot be provided to the applicant. It is also stated that there are several things that are discussed in the meeting, all of which relate to various internal decisions, which have no relationship to any public activity or interest. Hence, the information sought is exempted from disclosure under section 8(1) (d) of the RTI Act, 2005.
